

CURRICULUM

Correct waste management identifies, as is known, a complex system of operations, the success of which is closely correlated with the professionalism used to achieve the set objectives. For these reasons ESPER (Study Body for Eco-sustainable Waste Planning) was born and operates as a research body which includes professionals who boast many years of experience in the various and complementary disciplines they belong to. All activities are carried out exclusively on behalf of public bodies or companies controlled by public bodies and concern in particular the planning of integrated separate waste collection services as well as the preparatory documents for the start-up of these services (specifications, technical specifications and calls for tenders, service card, area and municipal regulations, communication projects, etc.), support for the implementation of the punctual tariff, the drafting of planning tools (Regional or Area Plans, Strategic Environmental Assessment procedures), the drafting of research and projects in the field of Circular Economy and the reduction of MSW production. The technical structure also takes care of all the activities relating to the Directorate for the execution of urban hygiene contracts (DEC).

The technical-economic analysis developed in the design activity were elaborated to develop the SCSi software patented at European level by ESPER for the detailed design of the integrated urban waste management services. This software was selected by ARPAV of Veneto on behalf of APAT (now ISPRA¹) for the simulation of the collection costs for territorial macro areas (ATO, Provinces, Regions, etc.) and allow an accurate and precise definition of the costs of each single fraction of waste and the elaboration of technical-economic and management scenarios such as allow the competent bodies and offices to make decisions with greater awareness in terms of: operational choices, service optimisation, service costs and expected results.
